- Proof of insurance must be provided. \$2 million General Liability, \$1 million each occurrence is required. Insurance for the event only can be purchased through MSL for \$50.
- Read, sign registration form, and return with proof of insurance and payment. Applications will be accepted on a first come basis subject to MSL approval.
